**A RESOLUTION ESTABLISHING THE CITY OF BACoor TECHNICAL SKILLS S.T.R.I.K.E. (SIPAG TALINO AT RESPONSABLENG INOBASYON PARA SA KABUHAYAN AT EDUKASYON) CENTER AND AUTHORIZING ITS SEEK ACCREDITATION WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA).**

**WHEREAS**, the STRIKE Livelihood Center was established during the administration of former Mayor ( now Congressman) Strike B. Revilla and was at the forefront of the city government's efforts to develop livelihood opportunities for the residents of the City of Bacoor.

**WHEREAS**, the STRIKE LIVELIHOOD TRAINING CENTER has been serving as the CITY OF BACoor TECHNICAL AND LIVELIHOOD SKILLS TRAINING CENTER, a program which has been implemented in the City of Bacoor and has been providing skills training necessary for the employment readiness of unemployed members of our City;

**WHEREAS**, through the years of its operation, the program has been implemented through community-based skills training in the City. The program dramatically increased job opportunities for the unemployed in the city through vigorous implementation of vocational technical skills training programs. The graduates have been referred for job placement for both local and overseas employment;

**WHEREAS**, it is high time that STRIKE LIVELIHOOD TRAINING CENTER be established in the City of Bacoor as the CITY OF BACoor TECHNICAL AND LIVELIHOOD SKILLS TRAINING CENTER, a vocational technical training center providing relevant, accessible, high quality and efficient technical education and skills development of high quality Filipino middle-level manpower responsive to and in accordance with the Philippine development goals in line with the SEAS reintegration development program;

**WHEREAS**, the Sangguniang Panlungsod believes that the services being implemented by the STRIKE LIVELIHOOD TRAINING CENTER may be institutionalized and established if converted to the CITY OF BACoor TECHNICAL AND LIVELIHOOD SKILLS TRAINING CENTER, in order that such may be sustained and strategically enhanced for the succeeding local city administration;

**WHEREAS**, the Sangguniang Panlungsod is one and in accord with the mission and vision of Hon. Lani Mercado-Revilla, City of Mayor of the City of Bacoor, in institutionalizing the STRIKE LIVELIHOOD TRAINING CENTER by establishing it as the CITY OF BACoor TECHNICAL AND LIVELIHOOD SKILLS TRAINING CENTER, City of Bacoor;

**NOW THEREFORE**, upon joint and unanimous motion of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in session assembled, THAT:

**Section 1.** "The STRIKE LIVELIHOOD TRAINING CENTER shall from hereon be established and known as the **CITY OF BACoor TECHNICAL SKILLS S.T.R.I.K.E. (Sipag Talino at Responsableng Inobasyon para sa Kabuhayan at Edukasyon) CENTER** that will provide relevant, accessible, high quality and efficient technical and skills development training and education in line with the Philippine Development Goals and consistent with the ASEAN Reintegration Development Program."

**Section 2.** "The CITY OF BACoor TECHNICAL SKILLS S.T.R.I.K.E. (Sipag Talino at Responsableng Inobasyon para sa Kabuhayan at Edukasyon) CENTER is hereby authorized to seek accreditation with the Technical Education and Skills Development Authority (TESDA) and take over the duties and functions of the STRIKE LIVELIHOOD CENTER."

**Section 3.** "Upon accreditation of the CITY OF BACoor TECHNICAL SKILLS S.T.R.I.K.E. (Sipag Talino at Responsableng Inobasyon para sa Kabuhayan at Edukasyon) CENTER by the TESDA, the Sangguniang Panlungsod shall, in coordination with the Office of the City Mayor, pass an ordinance providing funds for the said institution and defining its role in the livelihood development programs of the administration of City Mayor Lani Mercado-Revilla."
