A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A SPECIFIC IMPLEMENTATION AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) (FIELD OFFICE) REGARDING THE IMPLEMENTATION OF THE SUPPLEMENTARY FEEDING PROGRAM OF THE CITY OF BACOOOR.
