A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A GENERAL MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) (FIELD OFFICE) REGARDING THE IMPLEMENTATION OF VARIOUS PROGRAMS AND PROJECTS OF THE CITY GOVERNMENT OF BACOOR.

**NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod of Bacoor, Province of Cavite, upon motion of Hon. Miguel N. Bautista duly seconded by Hon. Reynaldo D. Palabrica in regular session duly assembled, to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign a "General Memorandum of Agreement" on behalf of the City Government of Bacoor with the DSWD Field Office covering the following programs:

- 1) Supplementary Feeding Program;
- 2) Pantawid Pamilyang Pilipino Program;
- 3) Sustainable Livelihood Program;
- 4) Kapit-bisig Laban sa Kahirapan-Comprehensive Integrated Delivery of Social Services (KALAHI-CIDSS);
- 5) Social Pension Program;
- 6) Supplemental Feeding Program; and
- 7) Bottom-Up Budgeting Projects.

**RESOLVED LASTLY**, to furnish the Office of the City Mayor, the DSWD Field Office, and other government offices and agencies concerned with copies of this Ordinance.
