A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) REGARDING THE PROPOSED DEPOSIT PICK-UP AND CASH DELIVERY SERVICES.

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Bacoor, Province of Cavite, upon joint motion of Hon. Reynaldo D. Palabrica and Hon. Apolonio I.
