A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE BUREAU OF INTERNAL REVENUE (BIR) COVERING VARIOUS ACTIVITIES NAMELY: (1) TO ENROLL THE CITY GOVERNMENT IN THE BIR'S ELECTRONIC FILING AND PAYMENT SYSTEM (BIR eFPS); (2) TO FILE THE RETURNS AND REMIT PERIODIC TAX PAYMENTS ELECTRONICALLY THROUGH THE SYSTEM; AND (3) TO AUTHORIZE THREE (3) OFFICERS TO ENROLL IN THE eFPS, TO RECEIVE AND HOLD THE PASSWORD AND USER ID FOR THE SYSTEM.

WHEREAS, the City Government of Bacoor has the intention to enroll in Development Bank of the Philippines' (DBP) BIR eFPS Facility;

WHEREAS, the City Mayor submitted a letter requesting the Sangguniang Panlungsod of Bacoor to pass a Resolution authorizing the City Mayor to sign a Memorandum of Agreement for and on behalf of the city government with the Bureau of Internal Revenue (BIR);

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Bacoor, Province of Cavite, upon motion of Hon. Reynaldo D. Palabrica duly seconded by Hon. Venus D. De Castro in regular session duly assembled, to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign a Memorandum of Agreement on behalf of the City Government of Bacoor with the BIR covering various activities namely: (1) to enroll the city government in the BIR's electronic filing and payment system (BIR eFPS); (2) to file the returns and remit periodic tax payments electronically through the system; and (3) to authorize three (3) officers to enroll in the eFPS, to receive and hold the password and user ID for the system.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the BIR, and other government offices and agencies concerned with copies of this Ordinance.


