**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE LOCAL GOVERNMENT OF NAIC, CAVITE REGARDING THE RELOCATION OF 700 INFORMAL SETTLER FAMILIES LIVING IN THE DANGER ZONES ALONG THE ZAPOTE-BACOR-LAS PIÑAS RIVER.**

**WHEREAS**, the City Government of Bacoor in partnership with the National Government through the National Housing Authority (NHA) has identified resettlement sites in Naic, Cavite for the relocation of about seven hundred (700) informal settler families living along the 3-meter legal easement and other danger zones along the Zapote-Bacoor-Las Piñas River.

**WHEREAS**, the Local Government of Naic, Cavite supports the city government in the relocation of its homeless constituents within the territorial jurisdiction of Naic, Cavite.

**WHEREAS**, the City Government of Bacoor with the assistance of various National Government Agencies (NGAs) and the Local Government of Naic, Cavite have already relocated 33 families to the NHA Naic Relocation Site last February 2017.

**WHEREAS**, the Local Government of Naic has requested the city government to provide "POST-RELOCATION ASSISTANCE" consisting of basic services, facilities, equipment and financial support which will cater to the needs of the relocated families as identified in the Resettlement Action Plan (RAP) prepared by the Local Government of Naic, Cavite.

**WHEREAS**, the Office of the City Mayor submitted a draft copy of a Memorandum of Agreement (MOA) to the Sangguniang Panlungsod for its review and consideration.

**NOW THEREFORE**, upon motion of Hon. Apolonio I. Advincula, Jr. duly seconded by Hon. Miguel N. Bautista, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod in regular session duly assembled to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign a Memorandum of Agreement between the City Government of Bacoor and the Local Government of Naic, Cavite regarding the relocation of 700 informal settler families living in the danger zones at the Zapote-Bacoor-Las Piñas River.

**RESOLVED LASTLY**, to furnish the Office of the City Mayor, the Local Government of Naic, Cavite and all concerned government offices with copies of this Resolution.
