A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MERCHANT AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACoor WITH THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP) REGARDING THE POINT OF SALE PAYMENT SYSTEM FOR REGULAR ATM/DEBIT TRANSACTIONS.

WHEREAS, the Development Bank of the Philippines (DBP) through its Point of Sale (POS) System, undertakes to make available to participating Cardholders, the opportunity to purchase or pay taxes and fees from various local government units;

WHEREAS, the City Government of Bacoor is legally mandated to engage in business and to deliver specific services to the transacting public. It agrees to participate in the POS (Point of Sale) System Service of the DBP and to honor cards issued by the participating member banks and/or accredited card issuers to enable cardholders to pay taxes and fees based on the terms and conditions specified under a draft Merchant Agreement;

WHEREAS, the DBP submitted a revised copy of the draft Merchant Agreement to be entered into by the City Mayor and DBP for and on behalf of the City Government of Bacoor to the Sangguniang Panlungsod for its review and consideration;

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Bacoor, Province of Cavite, upon motion of Hon. Reynaldo D. Palabrica duly seconded by Hon. Miguel N. Bautista in regular session duly assembled, to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign a Merchant Agreement on behalf of the City Government of Bacoor with the DBP for Point of Sale Payment System for Regular ATM/Debit Transaction.






