A RESOLUTION EXPRESSING THE SUPPORT OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOOR TO THE FULL IMPLEMENTATION OF THE CIVIL SERVICE COMMISSION'S MEMORANDUM CIRCULAR NO. 17, SERIES OF 2009 IMPLEMENTING THE 100% SMOKE-FREE ENVIRONMENT POLICY IN ALL OFFICES AND FACILITIES OWNED BY THE LOCAL GOVERNMENT OF THE CITY OF BACOOR.

WHEREAS, the Civil Service Commission (CSC) issued Memorandum Circular No. 17, Series of 2017 regarding the "Smoking Prohibition Based on 100 % Smoke-Free Environment Policy" which prohibits smoking in or on the premises, building grounds of government agencies providing health, education and/or social welfare and development services except for open spaces designated as "smoking area" as defined in the guidelines of the policy in order to ensure a healthy and productive workforce;

WHEREAS, the CSC also partnered with the Department of Health (DOH) in the promulgation of a Joint Memorandum Circular (JMC) No. 2010-01 on the "Protection of the Bureaucracy Against Tobacco Industry Intervention". It provides guidelines for the bureaucracy's interactions with the tobacco industry particularly in prohibiting government officials and employees from doing unnecessary interaction with the tobacco industry.

WHEREAS, the Office of the City Mayor sent a letter request to the Sangguniang Panlungsod for a resolution implementing and adopting the abovementioned circulars for a "Smoke-Free Bacoor City Hall";

NOW THEREFORE, after deliberation, upon motion of Hon. Reynaldo D. Palabrica unanimously seconded by the councilors present in regular session duly assembled, **BE IT RESOLVED AS IT HEREBY RESOLVED** by the Sangguniang Panlungsod to express its support to the full implementation of the Civil Service Commission's Memorandum Circular No. 17, Series of 2009 implementing the 100% Smoke-Free Environment Policy in all offices and facilities owned by the Local Government of the City of Bacoor.
