A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE LAND BANK OF THE PHILIPPINES (LBP) FOR MOBILE-BASED SAVINGS-LINKED SALARY LOAN FACILITY TO QUALIFIED EMPLOYEES OF THE CITY GOVERNMENT.

**WHEREAS**, the City Government of Bacoor requested Land Bank of the Philippines to extend its "Mobile-Based Savings-Linked Salary Loan Facility" to its qualified employees.

**WHEREAS**, Land Bank of the Philippines (LBP) offers a Mobile-based Savings-linked Salary Loan Facility to encourage savings and provide a loan window to qualified employees;

**WHEREAS**, LBP aims to encourage the city government employees to save a portion of their monthly income (from salaries, bonuses and other monetary benefits) for any personal purpose such as education, planned vacation, business capital, purchase of vehicle/real estate/other properties, or for future and emergency use;

**WHEREAS**, a draft copy of Memorandum of Agreement for the abovementioned loan facility to qualified city employees was endorsed by the Office of the City Mayor for the review of the Sangguniang Panlungsod;

**NOW, THEREFORE**, after careful deliberation, on motion of Hon. Reynaldo D. Palabrica duly seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement, on behalf of the City Government of Bacoor with the Land Bank of the Philippines (LBP) for "Mobile-Based Savings-Linked Salary Loan Facility" to qualified city employees.


