A RESOLUTION RENAMING THE CITY LIVELIHOOD TRAINING CENTER AT BARANGAY SAN NICOLAS II, IN THE CITY OF BACoor, CAVITE TO THE RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC (REVILLA) CENTER AND AUTHORIZING IT TO SEEK ACCREDITATION WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA).

WHEREAS, the building being used by the City Livelihood Unit situated at Barangay San Nicolas II was constructed for the purpose of providing livelihood and technical skills training to economically distressed residents of the City of Bacoor.

WHEREAS, while the said facility successfully achieved the purpose for which it was created and provided job opportunities to thousands of Bacoor City residents. Its present name does not fully encompass the dreams and aspirations of the forefathers of the city for its economically depressed residents.

WHEREAS, it is high time that the CITY LIVELIHOOD TRAINING CENTER be established in the City of Bacoor as the **RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC (REVILLA) CENTER**, a vocational technical training center providing relevant, accessible, high quality and efficient technical education and skills development of high quality Filipino middle-level manpower responsive to and in accordance with the Philippine development goals in line with the SEAS reintegration development program;

WHEREAS, the Sangguniang Panlungsod believes that the services being implemented by the CITY LIVELIHOOD TRAINING CENTER may be institutionalized and established if converted to the **RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC (REVILLA) CENTER**, in order that such may be sustained and strategically enhanced for the succeeding local city administration;

WHEREAS, the Sangguniang Panlungsod is one and in accord with the mission and vision of Hon. Lani Mercado-Revilla, City Mayor of the City of Bacoor, in institutionalizing the CITY LIVELIHOOD TRAINING CENTER by establishing it as the **RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC (REVILLA) CENTER**, City of Bacoor;

NOW THEREFORE, upon joint and unanimous motion of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in session assembled, THAT:

Section 1. The CITY LIVELIHOOD TRAINING CENTER shall from hereon be established and known as the **RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC (REVILLA) CENTER** that will provide relevant, accessible, high quality and efficient technical and skills development training and education in line with the Philippine Development Goals and consistent with the ASEAN Reintegration Development Program.

Section 2. The **RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC (REVILLA) CENTER** is hereby authorized to seek accreditation with the Technical Education and Skills Development Authority (TESDA) and take over the duties and functions of the CITY LIVELIHOOD TRAINING CENTER.

Section 3. Upon accreditation of the **RESOURCES EDUCATION VOCATIONAL INSTRUCTION LIVELIHOOD LEARNING ACADEMIC (REVILLA) CENTER** by the TESDA, the Sangguniang Panlungsod shall, in coordination with the Office of the City Mayor, pass an ordinance providing funds for the said institution and defining its role in the livelihood development programs of the administration of City Mayor Lani Mercado-Revilla.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the City Livelihood Office, the TESDA and other government offices and agencies concerned with copies of this Resolution.
