A RESOLUTION ENDORSING TO THE DEPARTMENT OF BUDGET AND MANAGEMENT THE LIST OF PRIORITY PROGRAMS/PROJECTS PROPOSED AND FORMULATED BY THE CITY DEVELOPMENT COUNCIL COMPRISED OF CONGRESSMAN STRIKE B. REVILLA, MAYOR LANI MERCADO-REVILLA, MEMBERS OF THE SANGGUNIANG PANLUNGSOD AND OTHER STAKEHOLDERS IN THE CITY OF BACoor WITH AN AGGREGATE AMOUNT OF TWENTY-SIX MILLION PESOS, PHILIPPINE CURRENCY (PHP26,000,000.00) AND AFFIRMING THE SAID PROGRAMS/ PROJECTS ARE PART OF THE DULY APPROVED LOCAL DEVELOPMENT INVESTMENT PROGRAM (LDIP) AND ANNUAL INVESTMENT PLAN (AIP) OF THE CITY OF BACoor IN COMPLIANCE WITH LOCAL BUDGET CIRCULAR NO. 114.

WHEREAS, local governments confront rising public expectations regarding the delivery of services. Despite more than two decades of implementation of Republic Act (RA) No. 7160 (Local Government Code of 1991), however, local governments still face the various challenges in the exercise of their devolved service delivery functions. Foremost among these is the raising of sufficient funds for local development;

WHEREAS, cognizant of the need to provide further support to the LGUs to enable them to fully carry out functions devolved to them while at the same time, building their capacity towards genuine fiscal autonomy, the National Government has scaled up its efforts to ensure meaningful devolution.

WHEREAS, to this end, the Local Government Support Fund (LGSF) was included in the FY 2017 General Appropriations Act (GAA), also known as Republic Act(RA) No. 10924, to cover the following:

- Financial assistance to LGUs, which shall support priority programs and projects of LGUs;
- Assistance to Disadvantaged Municipalities (ADM); and
- Conditional Matching Grant to Provinces for Road Repair, Rehabilitation and Improvement (CMGP).

WHEREAS, the Department of Budget and Management (DBM) issued Local Budget Circular No. 114 on March 6, 2017, providing for GUIDELINES ON THE RELEASE AND UTILIZATION OF THE FY2017 LOCAL GOVERNMENT SUPPORT FUND – FINANCIAL ASSISTANCE TO LOCAL GOVERNMENT UNITS (LGSF—FA TO LGUs);

WHEREAS, among the requirements for the use and release of the LGSF-FA to LGUs is a request for the release of funds chargeable against the LGSF-FA signed by the Local Chief Executive (LCE) and submitted to the DBM, supported by the following:

- a) A list of priority programs and/or projects to be implemented signed by the LCE;
- b) Sanggunian Resolution endorsing the list of priority programs/projects, and affirming that such programs/projects are part of the duly approved Local Development Investment Program (LDIP) and Annual Investment Program (AIP);

WHEREAS, the City Development Council comprised of Congressman Strike B. Revilla, Mayor Lani Mercado Revilla, the members of the Sangguniang Panlungsod and other stakeholders of the city formulated a list of projects and programs to be funded under the LGSF as part of the LDIP and AIP of the city government and submitted the same to the Sanggunian with a request that the council pass a resolution endorsing the same to the DBM in compliance with Local Budget Circular No. 114.

NOW, THEREFORE, BE IT RESOLVED AS THIS RESOLVES, to endorse the herein attached list of priority programs/projects signed and to be implemented by the Mayor of the City of Bacoor, with an aggregate amount of **TWENTY-SIX MILLION PESOS, PHILIPPINE CURRENCY (PHP26,000,000.00)**, said list made part and integral to this resolution, and affirming that such programs/projects are part of the duly approved Local Development Investment Program and Annual Investment Program of the City of Bacoor.

BE IT RESOLVED FURTHER to provide a copy of this Resolution to the Department of Budget and Management in compliance with Local Budget Circular No. 114 for the use and release of the LGSF-FA to the City of Bacoor and to other government agencies and offices concerned.
