A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH - TREATMENT AND REHABILITATION CENTER, TAGAYTAY CITY (DOH-TRC) FOR AND ON BEHALF OF THE BACoor CITY GOVERNMENT ON THE "DRUG REHABILITATION PROGRAM".

WHEREAS, the Department of Health- Treatment and Rehabilitation Center, Tagaytay City (DOH-TRC) is a government agency mandated by law to treat and rehabilitate dangerous drug dependent;

WHEREAS, the Bacoor City Government aims to transfer the city into a "drug free city" and provide effective anti-illegal drug advocacy through the cooperation of the DOH, Philippine National Police (PNP) and other government agencies in enforcing the laws against the trafficking and use of dangerous drugs.

WHEREAS, to achieve the foregoing endeavor, the DOH-TRC agrees to assist the City of Bacoor, through its City Health Office (CHO) by way of treatment and rehabilitation of drug dependents in order to re-integrate them into society;

WHEREAS, the Office of the City Mayor submitted a draft Memorandum of Agreement to the Sangguniang Panlungsod for review and consideration;
