A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A DEED OF ABSOLUTE SALE BETWEEN THE CITY GOVERNMENT OF BACOOR AND MS. ELISA ESPIRITU TORTONA.

WHEREAS, the City Government of Bacoor intends to buy the said lots for the construction of multi purpose buildings for Barangay Kaingin and for other public uses.

WHEREAS, the Office of the City Mayor submitted a draft Deed of Absolute Sale that involves the sale of the above-mentioned properties to the Sangguniang Panlungsod for its review and consideration.

NOW THEREFORE, upon motion of Councilor Reynaldo D. Palabrica duly seconded by Councilors Edwin G. Gawaran and Michael E. Solis in its 18th regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign a Deed of Absolute Sale with Ms. Elisa Espiritu Tortona for and on behalf of the City Government of Bacoor, Cavite. **PROVIDED** that the City Legal Services Office is hereby directed to furnish the Sangguniang Panlungsod with a copy of Ms. Tortona's acceptance of the City Mayor's offer to buy her properties dated 1 March 2017.

RESOLVED LASTLY, to furnish the Office of the City Mayor, Ms. Tortona, the Office of City Legal Services, and all concerned government offices and agencies with copies of this Resolution.
