



CITY RESOLUTION NO. CR 2017-062

A RESOLUTION HAILING THE MERITS OF ESTABLISHING A PUBLIC FACILITY WITHIN THE CITY OF BACCOOR TO BE KNOWN AND REFERRED TO AS THE "MUSEO DE BACCOOR" THAT WILL HOUSE A PUBLIC LIBRARY, PUBLIC MUSEUM, AND PUBLIC ARCHIVES FOR THE CITY OF BACCOOR, CAVITE AND ENDORSING THE SAID PROJECT TO THE OFFICE OF CONGRESSMAN STRIKE B. REVILLA AND TO THE TOURISM INFRASTRUCTURE AND ENTERPRISES ZONE AUTHORITY (TIEZA).

WHEREAS, on 16 February 2017, the Sangguniang Panlungsod was furnished by the Office of the City Mayor with a copy of a letter dated 15 February 2017 signed by City Engineer Robert M. San Jose requesting, among others, the approval of a Resolution explaining the merits of constructing the proposed "Museo De Bacoor".

WHEREAS, the Museo De Bacoor is envisioned to be constructed on the present site of the Hall of Justice, a City Health Center, and a post office all situated in Barangay Taging Dagat.

WHEREAS, the proposed site of the "Museo De Bacoor" was also the original site of the first municipal hall of the town of Bacoor during the Spanish regime and faces the St. Michael Parish Church where Father Mariano Gomez, worked as its first Filipino parish priest before he was martyred by the Spaniards on 17 February 1872. It also faces the city's very first public park.

WHEREAS, the foregoing assertions indubitably show that the proposed location of the Museo De Bacoor is the historic center of the City of Bacoor and should, perforce, be the focal point of the city government's tourism and cultural promotions program.

WHEREAS, the Sangguniang Panlungsod recognized this salient fact and mandated the creation of a public facility that will host a public library, public museum, and public archives on the said site through the city's Comprehensive Land Use Plan and Comprehensive Development Plan to be known and referred to as the "Museo De Bacoor".

NOW THEREFORE, upon joint and unanimous motion of the Body in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod that the proposed public facility intended to be constructed in Barangay Tabing Dagat, City of Bacoor, Cavite to be known and referred to as the "Museo De Bacoor" shall boost the tourism and cultural promotions program of the city government as it would house a library, museum, and archives where the public may be educated about the city's historic past.

RESOLVED FURTHER, to endorse the said project to the office of Congressman Strike B. Revilla of the 2nd Legislative District of the Province of Cavite and to the Tourism Infrastructure and Enterprises Zone Authority (TIEZA).

RESOLVED LASTLY, to furnish all government offices and agencies concerned with copies of this Resolution.
