A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACoor WITH THE BUREAU OF FISHERIES AND AQUATIC RESOURCES (BFAR) AND WITH THE PHILIPPINE FISHERIES DEVELOPMENT AUTHORITY (PFDA) REGARDING THE ESTABLISHMENT OF A COMMUNITY FISH LANDING CENTER (CFLC) AT BARANGAY SINEGUELASAN, CITY OF BACoor, CAVITE.

WHEREAS, Presidential Decree No. 977, as amended by Executive Order No. 772, authorizes the Philippine Fisheries Development Authority (PFDA) to prepare, adopt and implement comprehensive plans for the overall development of fish ports and complexes within its jurisdiction;

WHEREAS, Republic Act No. 7160, otherwise known as the "Local Government Code of 1991", mandate Local Government Units to provide its constituents with extension facilities related to agriculture and fishery activities which include water and soil resource utilization and conservation projects and the enforcement of fishery laws in municipal waters;

WHEREAS, the establishment of fisheries post-harvest infrastructure and facilities, particularly Community Fish Landing Centers (CFLCs), is part of the on-going collaboration between the Bureau Of Fisheries And Aquatic Resources (BFAR) , Philippine Fisheries Development Authority (PFDA) and the Local Government Units (LGUs) and other partner government agencies in line with the fisheries poverty reduction framework featured in the Target Program of BFAR;

WHEREAS, a draft copy of a Memorandum of Agreement among the BFAR, PFDA and city government was sent by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

NOW THEREFORE, upon motion of Councilor Gaudencio P. Nolasco unanimously seconded by all the councilors present in regular session duly assembled **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign a Memorandum of Agreement for and on behalf of the City Government of Bacoor with the Bureau of Fisheries and Aquatic Resources (BFAR) and




