WHEREAS, the Office of the City Mayor submitted the proposed Supplemental Investment Program (SIP) for the Supplemental Budget No. 2 for Calendar Year 2017 of the City of Bacoor in the amount of **Ninety Three Million Ninety Thousand Pesos (PhP93,090,000.00)** covering the personal, current operating expenditures and capital outlays that require additional funding for the enactment of an appropriation ordinance.
