A RESOLUTION GRANTING THE BARANGAY BOUNDARY DISPUTES RESOLUTION (BBDR) TASK FORCE AN ADDITIONAL 365 DAYS WITHIN WHICH TO FINISH ITS TASK OF DETERMINING THE POLITICAL BOUNDARIES OF VARIOUS BARANGAYS IN THE CITY OF BACOOR.

WHEREAS, on 20 February 2017 the Sangguniang Panlungsod passed City Resolution No. CR 2017-033 entitled: "A Resolution Creating the Barangay Boundary Disputes Resolution (BBDR) Task Force of the City of Bacoor" in order to create a special body tasked with the duty of providing technical assistance to the city council in resolving barangay boundary disputes.

WHEREAS, Section 4 of the said resolution pegged the period of existence of the Task Force to only three (3) months.

WHEREAS, the BBDR Task Force headed by Engr. Arthur S. San Jose, submitted a preliminary report together with a request that the said body be given an additional time to finish its report as the 3-month period originally granted to it is not enough for it to finish its assigned task.

WHEREAS, the city council deliberated on the above-mentioned matter and decided to give additional time to the BBDR Task Force to finish its tasks in resolving the boundary disputes of various barangays.

NOW, THEREFORE, upon motion of Councilor Reynaldo D. Palabrica unanimously seconded by all the councilors present in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to grant the Barangay Boundary Disputes Resolution (BBDR) Task Force an additional 365 days within which to finish its task of determining the political boundaries of various barangays in the City of Bacoor. **PROVIDED** that the said 365-day extension shall commence on 19 June 2017 and shall last until 19 June 2018 with the admonition to all the members of the Task Force to finish its report as soon as possible.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the BBDR Task Force, the Punong Barangay of all the barangays of the City of Bacoor, and all concerned government offices and agencies with copies of this Resolution.
