A RESOLUTION COMMEMORATING THE 1898 BACOOR ASSEMBLY HELD ON AUGUST 1, 1898, REQUESTING THE NATIONAL HISTORICAL COMMISSION OF THE PHILIPPINES (NHCP) TO GRANT FUNDS IN FAVOR OF THE BACOOR CITY GOVERNMENT IN CELEBRATION OF THE SAID HISTORICAL EVENT AND FOR IT TO ERECT A MARKER COMMEMORATING THE SAID HISTORIC EVENT IN FILIPINO, SPANISH AND ENGLISH.

WHEREAS, on 19 June 2017, the Office of the City Administrator endorsed a letter requesting the Sangguniang Panlungsod to pass a resolution commemorating the 1898 Bacoor Assembly that was held on 1 August 1898 and requesting the National Historical Commission of the Philippines (NHCP) to grant funds in favor of the city government to celebrate the said event;

WHEREAS, various historical documents gathered by the Bacoor Historical Society and by the City Tourism Development Office revealed that the 200 members of the Bacoor Assembly, which was comprised of representatives of the eight (8) provinces that first revolted against the Spanish colonial authorities, signed an official declaration of independence on 1 August 1898 at the Cuenca Residence in the then Municipality of Bacoor;

WHEREAS, the significance of the said historical event can not be gainsaid as the authenticity of the said records were reportedly confirmed by the NHCP.

WHEREAS, the celebration of 1898 Bacoor Assembly is one of the cultural and historical events in the City of Bacoor to be initiated by the City Mayor Hon. Lanie Mercado-Revilla in coordination with the City Tourism Development Office and will be held on 1 August 2017;

WHEREAS, in relation to the said event, the city government requests the NHCP for funds for the following projects: (1) the installation of a marker commemorating the said event in Filipino, Spanish, and English, and (2) for the celebration of the said event.

NOW THEREFORE, upon motion of Councilor Rowena Bautista-Mendiola duly seconded by Councilor Reynaldo D. Palabrica, in its regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of Bacoor, Province of Cavite to request the NHCP for funds for the following projects: (1) the
