**A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF HEALTH – REGIONAL OFFICE 4A FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR ON THE ESTABLISHMENT OF THE "BACOR SOCIAL HYGIENE CLINIC."**

**WHEREAS**, Administrative Order No. 18, Series of 1995 standardized the clinical management of Human Immunodeficiency Virus (HIV) and Acquired Immune Deficiency Syndrome (AIDS) through the establishment of an HIV and AIDS Core Team (HACT) in every tertiary hospital being retained by the Department of Health (DOH);

**WHEREAS**, the DOH-Regional Office 4A as the lead agency of government in the CALABARZON on HIV and AIDS prevention and control, identifies both government and private health facilities, including provincial and local government hospitals as treatment hubs to provide services related to HIV And AIDS;

**WHEREAS**, the City Government of Bacoor aims to establish the "Bacoor Social Hygiene Clinic" within the city wherein its functional medical team has to undergo capacity building on the clinical management of HIV and AIDS;

**WHEREAS**, the Bacoor Social Hygiene Clinic will be considered as one of the official DOH-designated satellite treatment hubs in the country that facilitates the provision of safe, comprehensive and compassionate care to HIV and AIDS patients;

**WHEREAS**, the Office of the City Mayor submitted a draft Memorandum of Agreement to the Sangguniang Panlungsod for review and consideration;
