A RESOLUTION AUTHORIZING THE CITY MAYOR TO SIGN A DEED OF DONATION BETWEEN THE BACOR SEAFRONT DEVELOPMENT CORPORATION AND THE CITY GOVERNMENT OF BACOR WITH THE BUREAU OF JAIL MANAGEMENT AND PENOLOGY REGION IV-A REGARDING THE DONATION OF A PARCEL OF LAND SITUATED IN BARANGAY SAN NICOLAS, CITY OF BACOR, CAVITE.

WHEREAS, the Bacoor Seafront Development Corporation bought a parcel of land from Ms. Mercillana Vizcarra Torres-Riego, one of the heirs of Leonardo M. Torres and Maxime Vizcarra, situated in Barangay San Nicolas with an area of 26,359 square meters.

WHEREAS, while the title over the said property is being processed in favor of Bacoor Seafront Development Corporation, the said corporation offered to donate a portion of the aforementioned property with an area of Five Thousand (5,000) square meters in favor of the local government of the City of Bacoor and the Bureau of Jail Management and Penology Region IV-A subject to certain conditions that the city government and the BJMP should comply with in order to make the said donation effective.

WHEREAS, a draft Deed of Donation covering 5,000-square meter lot and containing the conditions adverted to above was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for review and consideration.

NOW, THEREFORE, after careful deliberation, on motion of Councilor Edwin G. Gawaran duly seconded by Councilor Venus De Castro in regular session duly assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign the Deed of Donation mentioned above for and on behalf of the City Government of Bacoor regarding the donation of a 5,000-square meter lot situated in Barangay San Nicolas, City of Bacoor, Cavite by the Bacoor Seafront Development Corporation in favor of the City Government.

RESOLVED LASTLY, to furnish the Office of the City Mayor, the Bacoor Seafront Development Corporation, the BJMP Region IV-A and all government offices concerned with copies of this resolution.
