A RESOLUTION PROVIDING ASSISTANCE, FINANCIAL OR OTHERWISE, TO THE PEOPLE OF MARAWI CITY DISPLACED AND AFFECTED BY THE MILITARY OPERATIONS AGAINST THE MAUTE GROUP.

WHEREAS, the present situation in Marawi City has affected so many families and innocent civilians that were caught in the middle of the military operations against the Maute Group.

WHEREAS, the Office of the Sangguniang Panlungsod has received a letter from the Office of the City Mayor requesting an authority to provide financial, or any other forms of assistance to the people of the City of Marawi that are displaced and affected by the military operations against the Maute Group.

WHEREAS, the said request was tackled by the council during its regular session and it was unanimously agreed upon by the members of the council to provide the said assistance.

NOW THEREFORE, during regular session assembled, upon unanimous motion of the Sangguniang Panlungsod, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to pass a resolution authorizing the city government to provide assistance, financial or otherwise, to the people of Marawi City who have been displaced and affected by the military operations against the Maute group.

RESOLVED LASTLY, to furnish the City Government of Marawi and other government agencies concerned with copies of this resolution.

UNANIMOUSLY ADOPTED this 14th day of August 2017 at the City of Bacoor during the 33rd regular session of the 3rd Sangguniang Panlungsod of the City of Bacoor.
