A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE UNIVERSITY OF PERPETUAL HELP (UPH) LAS PIÑAS INC. AND WITH THE DEPARTMENT OF EDUCATION (DepEd) REGARDING THE TUITION DISCOUNT BEING OFFERED BY UPH IN FAVOR OF PUBLIC SCHOOL TEACHERS WHO WILL ENROL IN ITS GRADUATE SCHOOL.

WHEREAS, the Office of the City Mayor submitted for review by the Sangguniang Panlungsod a draft Memorandum of Agreement among the city government, the University of Perpetual Help- Las Piñas Inc. (UPH) and the Department of Education;

WHEREAS, a cursory glance at the terms and conditions of the proposed agreement reveal that UPH is offering to give a 60% discount in the tuition of public school teachers from the City of Bacoor who will enroll in any of the education programs of Graduate School of the said university;

WHEREAS, the said agreement also provides that the said discount may only be availed of if at least 75 public school teachers from the City of Bacoor will enroll in the said education programs;

WHEREAS, the proposed agreement also provides that the City Government of Bacoor will shoulder the water and electricity expenses in Habay, Maliksi, Molino and Mambog Elementary Schools which will be used as venues for the graduate classes once a week (6:00PM to 9:00PM);

WHEREAS, the Office of the City Mayor requests the Sangguniang Panlungsod to pass a resolution authorizing the City Mayor to sign the said agreement;
