A RESOLUTION AUTHORIZING CITY MAYOR LANI HON. MERCADO-REVILLA TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF INFORMATION AND COMMUNICATIONS TECHNOLOGY (DICT) ON THE PROJECT OF THE NATIONAL GOVERNMENT TO PROVIDE FREE WIRELESS FIDELITY (WI-FI) INTERNET ACCESS IN SELECTED PUBLIC PLACES WITHIN THE CITY OF BACOOR, CAVITE.

WHEREAS, the national government through the Department of Information and Communications Technology (DICT) intends to provide free wireless fidelity (wi-fi) internet access in selected public places across the Philippines to accelerate economic, social and educational opportunities and reduce the digital divide under e-Filipino Program of the national government.

WHEREAS, the project is envisioned to provide free wi-fi internet access in public places nationwide which will initially cover selected cities and municipalities and public places such as public school, libraries, hospitals, rural health units, police stations, state universities and colleges, public transport terminals, seaports and airports.

WHEREAS, the DICT and the City Government of Bacoor have agreed to cooperate and jointly commit in promoting development through the use of information and communications for effective and efficient national and local governance in the country pursuant to the Memorandum of Understanding signed by Department of the Interior and Local Government (DILG), League of Municipalities of the Philippines (LMP) and the DICT last July 24, 2015.
