A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOOR WITH THE PROVINCIAL GOVERNMENT OF CAVITE REGARDING THE FINANCIAL ASSISTANCE TO BE GRANTED TO THE CITY GOVERNMENT.

**WHEREAS**, a draft Memorandum of Agreement was sent by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration.

**WHEREAS**, the said agreement pertains to the financial assistance to be granted by the Provincial Government to the City Government of Bacoor for the implementation of its priority programs and projects/trainings.

**WHEREAS**, the Sangguniang Panlungsod deliberated on the said agreement and found the provisions thereof to be in accordance with law and advantageous to the government.

**NOW THEREFORE**, upon unanimous motion of all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to authorize the City Mayor, Hon. Lani Mercado-Revilla, to sign and enter into a Memorandum of Agreement for and on behalf of the City Government of Bacoor with the Provincial Government of Cavite regarding the financial assistance to be granted to the city government.
