









A RESOLUTION REQUESTING THE PHILIPPINE ROAD BOARD TO PROVIDE FUNDING FOR THE REHABILITATION/UPGRADING OF VARIOUS STREETLIGHTS ALONG MAJOR THOROUGHFARES WITHIN THE CITY OF BACOR AND EXPRESSING THE WILLINGNESS OF THE SANGGUNIANG PANLUNGSOD OF THE CITY OF BACOR, CAVITE, TO FUND THE MAINTENANCE AND THE ELECTRICITY CONSUMPTION OF THE SAID VARIOUS STREETLIGHTS INSTALLED BY THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS.

**WHEREAS**, the Department of Public Works and Highways (DPWH) installed various streetlights along major thoroughfares that are within the jurisdiction of the City of Bacoor, Cavite.

**WHEREAS**, there is a need to rehabilitate and upgrade the following streetlights installed by the DPWH within the City of Bacoor, to wit:

- Molino-Salawag Road from Zapote to Dasmariñas City boundary;
- Marcos Alvarez Highway from Magdiwang Road intersection;
- Tirona Highway from Aguinaldo Highway intersection to Mabolo;
- Evangelista Road from Mabolo to Talaba;
- Coastal Road;
- Gen. E. Aguinaldo Highway Extension; and
- Daang Hari Road from Alabang to Imus City boundary.

**WHEREAS**, part of the condition of the Philippine Road Board (the agency under the DPWH that will fund the said road safety project) for the rehabilitation and upgrading of the said streetlights is that city government should be willing to maintain the facilities and to pay for the electricity consumption of the said amenities.

**NOW THEREFORE**, upon unanimous motion of all the councilors present in a regular session duly assembled **BE IT**




