A RESOLUTION REQUESTING THE PHILIPPINE ROAD BOARD TO PROVIDE FUNDING FOR THE CONSTRUCTION OF PEDESTRIAN OVERPASSES WITH ELEVATORS FOR PERSONS WITH DISABILITIES (PWD) WITHIN THE CITY OF BACOR, CAVITE.

WHEREAS, the Philippine Road Board dreams of providing a maintained, safe, environmentally balanced and user-friendly road network in the whole country.

WHEREAS, there is a need to construct the pedestrian overpasses with elevators for the use of Persons with Disabilities (PWD) within the City of Bacoor specifically at the following locations:

- Talaba (St. Dominic) Junction, Talaba 5;
- Bacoor Boulevard in front of Bacoor Government Center, Brgy. Bayanan; and
- In front of SM Molino, Molino 4.

WHEREAS, part of the condition of the Philippine Road Board (the agency under the DPWH that will fund the said road safety project) for the construction of pedestrian overpasses with PWD's Elevator is that the city government should be willing to maintain the facilities.




