CITY RESOLUTION NO. CR 2017-112

A RESOLUTION DECLARING THE EXISTENCE OF A STATE OF CALAMITY IN THE ENTIRE CITY OF BACOOR DUE TO WIDESPREAD FLOODING BROUGHT ABOUT BY TROPICAL STORM "MARING" AND AUTHORIZING THE CITY MAYOR TO DISBURSE THE AMOUNT OF FIVE MILLION PESOS (PHP 5,000,000.00) FROM THE DISASTER RISK REDUCTION AND MANAGEMENT FUND TO BE USED FOR RELIEF AND REHABILITATION OPERATIONS AND OTHER INCIDENTAL EXPENSES RELATIVE THERETO.

WHEREAS, on 12 September 2017, the Bacoor Disaster Risk Reduction and Management Council (BDRRMC) passed its Resolution No. 05 entitled: "A Resolution Requesting the Sangguniang Panlungsod to Declare the Existence of A State of Calamity in the Entire City of Bacoor Due to Flashfloods Brought About by the Onslaught of Tropical Depression 'MARING' ";

WHEREAS, the continuous flooding brought about by the onslaught of Tropical Depression "Maring" inundated large parts of the City of Bacoor affecting around 26, 135 families all over the city;

WHEREAS, after deliberating on BDRRMC Resolution No. 05 and the various supporting documents presented before it by the City Social Welfare and Development Office (CSWDO), the Sangguniang Panlungsod unanimously voted in favor of declaring the entire City of Bacoor under a state of calamity.

NOW, THEREFORE, BE IT RESOLVED AS IT IS HEREBY RESOLVED, by the Sangguniang Panlungsod of Bacoor, Province of Cavite, in regular session duly assembled to declare the entire City of Bacoor under a **STATE OF CALAMITY** due to the extensive damages to property caused by Tropical Storm "Maring" and authorizing the City Mayor, Hon. Lani Mercado-Revilla, to disburse **FIVE MILLION PESOS (PHP 5,000,000.00)** from the Disaster Risk Reduction and Management Fund to be used for relief and rehabilitation operations and other incidental expenses related thereto.






