





**A RESOLUTION URGING THE BACOOR TRAFFIC MANAGEMENT DEPARTMENT AND CITY ENGINEERING OFFICE TO STRICTLY IMPLEMENT THE PROVISIONS IN THE BACOOR TRAFFIC CODE REGARDING MOTORCYCLE LANES AND SPEED LIMIT WITHIN THE CITY OF BACOOR.**

**WHEREAS**, it was observed that a growing number of accidents have been reported involving overspeeding motorcycle drivers who do not use the motorcycle lanes on various public roads.

**WHEREAS**, because of such development, the Sangguniang Panlungsod believes that the Bacoor Traffic Management Department (BTMD) should strictly implement the provisions of the Bacoor Traffic Code on speeding and on motorcycle lanes on various public roads while the City Engineering Office should put up sufficient numbers of road safety signs.

**NOW THEREFORE**, upon motion of Hons. Reynaldo Palabrica and Alejandro Gutierrez, unanimously seconded by the members present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED**, by the Sangguniang Panlungsod to pass a resolution urging the Bacoor Traffic Management Department and City Engineering Office to strictly implement the provisions in the Bacoor Traffic Code regarding motorcycle lanes and speed limit within the City of Bacoor.
