WHEREAS, Social Housing Finance Corporation (SHFC) is a government-owned corporation tasked to be the lead government agency to undertake social housing programs in low income communities;

WHEREAS, among the priorities of the City Government of Bacoor is to provide decent and affordable housing to its constituents and develop communities that will spur the future development of the City of Bacoor;

WHEREAS, the City Government of Bacoor received from SHFC a Letter of Intent signifying its interest to occupy an office space within the Bacoor Government Center so that it can more readily facilitate the implementation of socialized housing projects in the City of Bacoor;

WHEREAS, a draft Memorandum of Agreement between the city government and the SHFC was submitted by the Office of the Mayor for the review and consideration of the Sangguniang Panlungsod;
