A RESOLUTION HONORING THE MEMORY OF THE HONORABLE LORENZO P. NOLASCO FOR HIS LONG YEARS OF EXEMPLARY AND DISTINGUISHED SERVICE TO THE PEOPLE OF THE CITY OF BACOOR, CAVITE.

WHEREAS, Hon. Lorenzo P. Nolasco began his career in public service in 1986 when he was first elected as Punong Barangay (then referred to as "Barangay Captain") of Mambog and served until 1995. He was then elected as a Kagawad of Barangay Mambog in 1995 and served until 1997.

WHEREAS, in 1998 , Hon. Nolasco was elected as a member of the Sangguniang Bayan of Bacoor, Cavite (now the Sangguniang Panlungsod after the conversion of Bacoor into a component city of the Province of Cavite in 2012) and served for three consecutive terms until June 30, 2007. Among the seminal local legislation he authored was Ordinance No. 1, Series of 1999 which regulated the operation of video game arcades in the then Municipality of Bacoor.

WHEREAS, Hon. Lorenzo P. Nolasco was known for his down-to-earth attitude in dealing with his constituents and his unfailing concern for the welfare of the masses. The passing of this exemplary public servant is a great loss to the people of Bacoor and to the thousands of people whose lives he touched. The Sangguniang Panlungsod bids goodbye to Councilor Lorenzo P. Nolasco whose hard work is now concluded. May he find eternal rest in the loving company of the Almighty God.
