





CITY RESOLUTION NO. CR 2017-122

**A RESOLUTION RESPECTFULLY RECOMMENDING TO THE CITY MAYOR TO AUTHORIZE THE SUSPENSION OF THE IMPLEMENTATION OF MUNICIPAL ORDINANCE NO. 25-S-2009 AS AMENDED (OTHERWISE KNOWN AS THE "MUSSEL/OYSTER FARMING ORDINANCE OF BACoor") IN VIEW OF PROPOSALS TO RECLAIM PORTIONS OF BACoor BAY.**

**WHEREAS**, the city government has received numerous unsolicited proposals from the private sector calling for the reclamation of certain portions of Bacoor Bay which form part of the municipal waters of the City of Bacoor.

**WHEREAS**, though the final approval of the said proposals does not fall within the purview of the powers of the city government, the possibility that the said proposals might be approved within the near future by the national government may not be discounted.

**WHEREAS**, hundreds of fisherfolk families depend upon the Bacoor Bay for their livelihood especially in relation to the operation of mussel and oyster farms.

**WHEREAS**, Municipal Ordinance No. 25 was passed by the erstwhile Sangguniang Bayan in 2009 for the purpose of regulating the operation of mussel and oyster farms operating within the municipal waters of the City of Bacoor and prevent environmental degradation. It was later amended by City Ordinance No. 2013-033. Under the said ordinance, operators of mussel and oyster farms located within the municipal waters of the city are required to pay fees to the city government annually for the exercise of the privilege to use the city's marine resources.

**WHEREAS**, the possibility that the said proposals to reclaim Bacoor Bay should give the city government enough reason to study the feasibility of suspending the implementation of Municipal Ordinance No. 25 as amended, in light of the economic impact of the said projects to the livelihood of the fisherfolk families to be affected thereby.






