



**A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) OF THE CITY OF BACOOR, PROVINCE OF CAVITE FOR CALENDAR YEAR 2017.**

**WHEREAS**, the Office of the City Mayor submitted the proposed Supplemental Investment Program (SIP) for the Supplemental Budget No. 3 for Calendar Year 2017 of the City of Bacoor in the amount of Fifteen Million Six Hundred Sixty Five Thousand Seven Hundred Fifty Pesos (PhP15,665,750.00) covering the current operating expenditures and capital outlays that require additional funding for the enactment of an appropriation ordinance.
