





A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A DEED OF ABSOLUTE SALE BETWEEN THE CITY GOVERNMENT OF BACOOR AND BAHAYANG PAG-ASA, INC.

WHEREAS, the general welfare clause of the Local Government Code of 1991 mandates the socio-economic development of communities within the territorial jurisdiction of various local government units in order to promote public welfare.

WHEREAS, Bahayang Pag-asa, Inc. is the registered owner of a parcel of land with an area of Two Hundred Two (202) square meters located at Lot 1, Block 2, Phase 2A, Bahayang Pag-asa Subdivision, Molino V, Bacoor City, Cavite as evidenced by Transfer Certificate of Title No. T-99047.

WHEREAS, the City Government of Bacoor intends to buy the said lot where a sub-station of the Philippine National Police (PNP) is located;

WHEREAS, the Office of the City Mayor submitted a draft Deed of Absolute Sale that involves the sale of the above-mentioned properties to the Sangguniang Panlungsod for its review and consideration.
