LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE PHILIPPINE DRUG ENFORCEMENT AGENCY (PDEA) REGIONAL OFFICE 4A ON THE CONSTRUCTION OF A PDEA SATELLITE OFFICE IN THE BACOR GOVERNMENT CENTER (BGC).

WHEREAS, Republic Act No. 9165, (also known as the Comprehensive Dangerous Drugs Act of 2002) created the Philippine Drug Enforcement Agency (PDEA) for the efficient and effective enforcement of various provisions of the said law.

WHEREAS, PDEA is empowered to establish and maintain satellite offices in local government units in the country;

WHEREAS, the City of Bacoor offered to host a PDEA satellite office within the Bacoor Government Center (BGC) located at Bacoor Boulevard, City of Bacoor, Cavite for the use by the PDEA Regional Office IV-A.

WHEREAS, the City of Bacoor is willing to provide to the PDEA, the necessary equipment and support personnel to run, operate and maintain the office as the Center for Anti-Drug Campaign within the city for the benefit of its constituents and general public.

WHEREAS, the Office of the City Mayor submitted a draft Memorandum of Agreement (MOA) to the Sangguniang Panlungsod for its review and consideration.

NOW THEREFORE, upon motion of Councilor Alejandro F. Gutierrez duly seconded by Councilor Apolonio I. 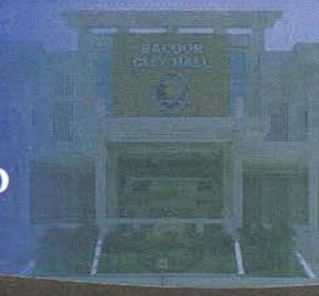
