A RESOLUTION APPROVING THE SUPPLEMENTAL FIVE (5) YEAR PLAN OF THE BACOR DISASTER RISK REDUCTION AND MANAGEMENT OFFICE ON THE UTILIZATION OF THE UNEXPENDED BALANCE OF THE 2016 LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND AMOUNTING TO ONE MILLION THREE HUNDRED TWENTY THREE THOUSAND ONE HUNDRED NINETY SEVEN PESOS AND FIFTY FIVE CENTAVOS (PHP1,323,197.55).
