**A RESOLUTION APPROVING THE ANNUAL INVESTMENT PROGRAM (AIP) OF THE CITY OF BACOOR, PROVINCE OF CAVITE FOR CALENDAR YEAR 2018.**

**WHEREAS**, on 09 October 2017, the City Development Council (CDC) of the City of Bacoor passed its Resolution No. 04A, Series of 2017 approving the Annual Investment Program (AIP) for the Year 2018 covering the programs/projects/activities of the City Government of Bacoor in the amount of **Two Billion Fifty Million Pesos (Php2,050,000,000.00)**.

**WHEREAS**, in compliance with the various pertinent provisions of RA 7160 and applicable government edicts and policies, the City Development Council formulated the Annual Investment Program for Calendar Year 2018 of the City of Bacoor.

**WHEREAS**, the Sangguniang Panlungsod deliberated on CDC Resolution No. 04A, Series of 2017 regarding the proposed Annual Investment Program for Calendar Year 2018 and unanimously voted to approve the same;

**WHEREFORE**, on motion of Hon. Reynaldo Palabrica unanimously seconded by all the councilors present in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod to ratify the Annual Investment Program for Calendar Year 2018 of the City of Bacoor.


