





CITY RESOLUTION NO. CR 2018-003 Series of 2018

A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE ENVIRONMENTAL MANAGEMENT BUREAU (EMB) REGIONAL OFFICE IV-A REGARDING THE ESTABLISHMENT/UPGRADING OF MATERIAL RECOVERY FACILITIES (MRFs).

WHEREAS, the Ecological Solid Waste Management Act of 2000 (RA 9003), mandates local government units to institute an ecological waste management program in order to prevent the destructions of the environment.

WHEREAS, Section 32 of RA 9003 required each barangay or clusters of barangays to establish materials recovery facilities (MRFs) within their territorial jurisdiction.

WHEREAS, the EMB is offering to assist the city government in upgrading the MRF of various barangays in the City of Bacoor through the Memorandum of Agreement, drawn for the said purpose.

NOW THEREFORE, during regular session assembled, upon motion of Hon. Reynaldo Palabrica seconded by Hon. Gaudencio Nolasco, the Sangguniang Panlungsod, **BE IT RESOLVED, AS IT IS HEREBY RESOLVED** to pass a resolution authorizing the City Mayor, Hon. Lani Mercado-Revilla to sign and enter into a Memorandum of Agreement with the Environmental Management Bureau (EMB) Regional Office IV-A regarding the establishment/upgrading of material recovery facilities (MRFs).

RESOLVED LASTLY, to furnish the Environmental Management Bureau (EMB) Regional Office IV-A and other government agencies concerned with copies of this resolution.
