



A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A MEMORANDUM OF AGREEMENT FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCCA) REGARDING THE IMPLEMENTATION OF THE "MUSIKO FESTIVAL".

**WHEREAS**, pursuant to Republic Act 7356, the National Commission for Culture and the Arts (NCCA) is mandated to encourage the continuing and balanced development of a culture by the people, conserve and promote the nation's cultural heritage, ensure the widest dissemination of artistic and cultural products and preserve and integrate traditional culture and its various creative expressions as a dynamic part of the national cultural mainstream;

**WHEREAS**, the City of Bacoor has been declared as the "Marching Band Capital of the Philippines" to promote the socio-cultural well-being of its residents the preservation and protection of its cultural heritage, and to ensure the advancement of the creative expressions of its residents;

**WHEREAS**, the "Musiko Festival" is a marching band competition to be launched by the city government to be held in the Philippines for the first time specifically in the City of Bacoor to be participated in by other cities with an existing marching band tradition;

**WHEREAS**, the said project proposed by the city government was supported and approved by the NCCA by granting financial assistance in the amount of Two Hundred Fifty Pesos (PhP250,000.00) to the city;

**WHEREAS**, a draft Memorandum of Agreement between NCCA and the city government on the implementation of the "Musiko Festival" was submitted by the Office of the City Mayor to the Sangguniang Panlungsod for its review and consideration.


