CITY RESOLUTION NO. CR 2018-007

Series of 2018

A RESOLUTION EXTENDING THE DEADLINE FOR THE PAYMENT AND/OR RENEWAL OF REAL PROPERTY TAXES AND BUSINESS PERMITS FROM JANUARY 20, 2018 TO JANUARY 31, 2018 TO ALLOW MORE TAXPAYERS TO AVAIL OF THE TWENTY PER CENT (20%) DISCOUNT ON THE SAID TAX AND LOCAL FEE.

WHEREAS, the period for the issuance and application of business permits as well as the payment of Real Property Taxes (RPT) was originally set until 20 January 2018.

WHEREAS, due however, to the influx of more applications for business permits and the clamor of the local business sector to give taxpayers more time to avail of the 20% discount given to those who pay their RPT and business permit fees early, the City Mayor requested the Sangguniang Panlungsod to extend the above-mentioned period until 31 January 2018.

NOW, THEREFORE, upon motion Hon. Rowena Bautista-Mendiola duly seconded by Hon. Apolonio I. Advincula Jr., in regular session assembled, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod of the City of Bacoor, Cavite to extend the deadline for the payment and/or renewal of real property taxes and business permit fees from January 20, 2018 to January 31, 2018 in order to allow more taxpayers to avail of the twenty per cent (20%) discount given to those who would pay the said tax and local fee early.

RESOLVED LASTLY, to furnish the Business Permit and Licensing Office (BPLO), the Office of the City Treasurer and all government offices concerned with copies of this resolution.
