



A RESOLUTION APPROVING THE SUPPLEMENTAL INVESTMENT PROGRAM (SIP) OF THE CITY OF BACOR, PROVINCE OF CAVITE FOR CALENDAR YEAR 2018.

WHEREAS, the Office of the City Mayor submitted the proposed Supplemental Investment Program (SIP) for the Supplemental Budget No. 1 for Calendar Year 2018 of the City of Bacoor in the amount of Eighteen Million One Hundred Seven Thousand Four Hundred Six Pesos (PhP18,107,406.00) covering the current operating expenditures and capital outlays that require additional funding for the enactment of an appropriation ordinance.

WHEREAS, the Sangguniang Panlungsod deliberated on the proposed Supplemental Investment Program (SIP) for Calendar Year 2018 and unanimously voted to approve the same;
