**A RESOLUTION AUTHORIZING THE CITY ENGINEER OF THE LOCAL GOVERNMENT OF THE CITY OF BACoor, CAVITE TO SIGN AND SUBMIT ALL APPLICATIONS FOR BUILDING PERMIT AND OTHER ANCILLARY PERMITS OF ALL FACILITIES AND PROJECTS OWNED AND/OR FUNDED BY THE CITY GOVERNMENT IN COMPLIANCE WITH THE PERTINENT PROVISIONS OF THE NATIONAL BUILDING CODE.**

**WHEREAS**, Section 301 of the National Building Code of the Philippines (Presidential Decree No. 1096) provides that "no person, firm or corporation, including any agency or instrumentality of the government shall erect, construct, alter, repair, move, convert or demolish any building or structure or cause the same to be done without first obtaining a building permit therefor from the Building Official assigned in the place where the subject building is located or the building work is to be done".

**WHEREAS**, the City Administrator, Mr. Jerome V. Oliveros, requested the Sangguniang Panlungsod in writing to pass a resolution authorizing the City Engineer to sign and submit all applications for building permits and other ancillary permits of all facilities and projects owned and/or fully funded by the city government in compliance with Section 301 of the National Building Code of the Philippines.

**WHEREAS**, the Sanggunian found merit in the said request as it would help the city government comply with the afore-quoted provision of PD 1096.


**NOW THEREFORE**, upon motion of Hon. Apolonio Advincula, Jr. seconded by Hon. Edwin Gawaran, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** by the Sangguniang Panlungsod in regular session duly assembled to pass a resolution authorizing the City Engineer to sign and submit all





