CITY RESOLUTION NO. CR 2018-015

A RESOLUTION ESTABLISHING THE BACOOR TRANSITIONAL SHELTER PROGRAM AT BARANGAY SALINAS 2, BACOOR CITY, CAVITE AND ALLOWING FOR THE MOBILIZATION OF THE VARIOUS RESOURCES OF THE CITY OF BACOOR FOR THE MOST EXPEDIENT EXECUTION OF THIS PROJECT.

WHEREAS, the Sangguniang Panlungsod passed City Resolution No. CR 2018-014 declaring the existence of a state of calamity in Barangay Tabing Dagat and authorizing the release of funds from the Disaster Risk Reduction and Management Fund for the relief and rehabilitation of internally displaced families and their damaged properties. At least 200 families were affected by the said fire and they cannot be allowed to go back and reconstruct their houses because they were held by stilts on the foreshore of Bacoor Bay.

WHEREAS, the City of Bacoor bought a property from Ms. Ines Espiritu Tortona located at Barangay Salinas, Bacoor City to be used as an in-city socialized housing relocation project site of the city;

WHEREAS, the City Mayor, the Hon. Lani Mercado-Revilla, desires to use the abovementioned property for the establishment of transitional shelter units which will be constructed immediately for the benefit of internally displaced families affected by the said fire in Barangay Tabing Dagat;

WHEREAS, the said parcel of land will be developed as a disaster-resilient transitional shelter area to be funded from the Twelve Million Pesos (PhP12,000,000.00) allocated by the National Housing Authority (NHA) intended for the city's property in Zapote (Soriano Property);

WHEREAS, the construction of the initial 120 units of pre-fabricated houses will cost Php200,000.00 per unit to be paid within four (4) years or about Six Million Pesos (PhP6,000,000.00) per year to be sourced from the Disaster Risk Reduction and Management Fund of Bacoor.
