A RESOLUTION TO CENSURE PUNONG BARANGAY FEDERICO H. ESPIRITU WITH A STERN WARNING THAT A REPEAT OF HIS FAILURE TO CONDUCT THE REQUISITE CONCILIATION PROCEEDINGS PRIOR TO THE ISSUANCE OF A CERTIFICATE TO FILE ACTION WOULD RESULT IN THE IMPOSITION OF STIFFER ADMINISTRATIVE SANCTIONS AGAINST HIM.

WHEREAS, a complaint was filed by Ms. Michelle Dizon against Mr. Federico Espiritu, Punong Barangay of Barangay Camposanto, for allegedly issuing a Certificate to File Action in favor of Ms. Elaine Nazareno against Ms. Dizon without undergoing the requisite conciliation proceedings.

WHEREAS, the hearings held by the Committee of Barangay Affairs on the said complaint confirmed that Punong Barangay Espiritu failed to conduct conciliation proceedings pursuant to Section 412 of Republic Act No. 7160 which provides that "No complaint, petition, action, or proceeding involving any matter within the authority of the lupon shall be filed or instituted directly in court or any other government office for adjudication, unless there has been a confrontation between parties before the lupon chairman or the pangkat and that no conciliation or settlement has been reached as certified by the lupon secretary or pangkat secretary as attested by the lupon chairman or pangkat chairman or unless the settlement has been repudiated by the parties thereto."

WHEREAS, the failure of Punong Barangay Espiritu to conduct the requisite conciliation proceedings is a clear violation of the law.
