A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT (DOLE) REGIONAL OFFICE IV-A REGARDING THE IMPLEMENTATION OF "GARMENTS MAKING PROGRAM" WITH AN APPROVED BUDGET OF TWO MILLION PESOS (PHP 2,000,000.00) UNDER THE DOLE INTEGRATED LIVELIHOOD AND EMERGENCY EMPLOYMENT PROGRAM (DILEEP) OR KABUHAYAN PROGRAM FOR CALENDAR YEAR 2018.

WHEREAS, DILEEP is DOLE's contribution to the governments' agenda of inclusive growth through massive job generation and substantial poverty reduction.




