WHEREAS, St. Luke's Medical Center – Global City, Inc. is committed to provide the safest possible milk to the newborn by ensuring safety in acquiring breastmilk from lactating women donors as well as in handling and dispensing pasteurized donor breast milk;

WHEREAS, the Office of the City Mayor submitted a draft Memorandum of Agreement to the Sangguniang Panlungsod for review and approval;






