WHEREAS, on 26 March 2018, the Office of the Sangguniang Panlungsod, received a letter from Ms. Janet B. Deriada, Branch Manager of SM Bacoor Cinemas, requesting the City Council to repeal Section 3C.01 of the Revenue Code of Barangay Habay 2 for allegedly violating Section 152 (d) of the Local Government Code of 1991 in relation to Section 152 (a) of the same law.

WHEREAS, the said matter was referred to the Committee on Games and Amusement.

WHEREAS, the Committee on Games and Amusement cannot conduct committee hearings on the said matter due to the forthcoming Barangay and Sangguniang Kabataan elections on May 14, 2018.

WHEREAS, due to the pre-occupation of the officials of Barangay Habay 2 with the various activities related to the coming polls, the committee recommends to hold in abeyance the implementation of Section 3C.01 of the Barangay Revenue code of Habay 2 while the same is being reviewed by the council.
