**WHEREAS**, the Ecological Solid Waste Management Act of 2000 also known as RA 9003, provides for an ecological solid waste management program creating the necessary institutional mechanisms and incentives, and appropriating funds therefor, and for other purposes.


**WHEREAS**, Section 8 of RA 9003, mandates the Department of Environment and Natural Resources (DENR) to provide support in the development of its program such as the establishment of a materials recovery facility (MRF) in every barangay (Section 32 RA 9003).


**WHEREAS**, the City Government of Bacoor, has been an advocate of environmental programs of the DENR regarding the conservation and rehabilitation of the environment.


