





A RESOLUTION AUTHORIZING THE CITY MAYOR, HON. LANI MERCADO-REVILLA, TO SIGN A USUFRUCT AGREEMENT WITH THE DEPARTMENT OF EDUCATION (CITY OF BACOR SCHOOL DIVISION) FOR AND ON BEHALF OF THE CITY GOVERNMENT OF BACOR, CAVITE.
