A RESOLUTION NAMING THE COURTROOM OF BRANCH 89 OF THE REGIONAL TRIAL COURT OF THE CITY BACOR AS THE "JUSTICE SERAFIN R. CUEVAS HALL" SITUATED IN THE HALL OF JUSTICE OF THE CITY OF BACOR TO HONOR THE MEMORY OF FORMER JUSTICE SERAFIN R. CUEVAS.

WHEREAS, former Supreme Court Justice Serafin R. Cuevas (25 June 1928-4 February 2014) was born in Bacoor, Cavite and served the Philippines in various capacities in his long and distinguished career as a member of the Philippine bar, as a member of the judiciary, and as a government official.

WHEREAS, Section 13 of Republic Act No. 7160 (the "Local Government Code of the City of Bacoor") in conjunction with Article 23 of the Rules and Regulation Implementing the Local Government Code of 1991 empowered the Sangguniang Panlungsod, in consultation with the National Historical Institute (now known as the National Historical Commission of the Philippines) to name public places owned by the city government after persons who have already passed on who have made a significant contribution to the welfare of the Filipino people.

WHEREAS, the Hall of Justice of the City of Bacoor is a public edifice owned by the city government. It was constructed using public funds in order to assist the judiciary in the effective administration of justice. Currently, Branch 89 of the Regional Trial Court of the City of Bacoor is situated in the Hall of Justice.

NOW THEREFORE, upon motion of Hon. Rowena Bautista-Mendiola, unanimously seconded by all the members of the Body, **BE IT RESOLVED AS IT IS HEREBY RESOLVED** to name the courtroom of Branch 89 of the Regional Trial Court of the City of Bacoor as the "**JUSTICE SERAFIN R. CUEVAS HALL**" in order to honor the memory of former Justice Serafin Cuevas and as a sign of gratitude for




