





A RESOLUTION NAMING THE COURTROOM OF BRANCH 19 OF THE REGIONAL TRIAL COURT OF THE CITY BACCOOR AS THE "BUENAVENTURA OCAMPO HALL" SITUATED IN THE HALL OF JUSTICE OF THE CITY OF BACCOOR TO HONOR THE MEMORY OF THE HONORABLE BUENAVENTURA OCAMPO.

WHEREAS, it is often said that Filipino tend to forget their heroes and their contributions in the growth of the Filipino nation. One such hero is the late Buenaventura Ocampo.

WHEREAS, the Honorable Buenaventura Ocampo was born in Bacoor, Cavite and served the Philippines in various capacities in his long and distinguished career as a member of the Philippine bar, as a member of the judiciary, and as a government official.

WHEREAS, Section 13 of Republic Act No. 7160 (the "Local Government Code of the City of Bacoor") in conjunction with Article 23 of the Rules and Regulation Implementing the Local Government Code of 1991 empowered the Sangguniang Panlungsod, in consultation with the National Historical Institute (now known as the National Historical Commission of the Philippines) to name public places owned by the city government after persons who have already passed on who have made a significant contribution to the welfare of the Filipino people.






